# TOWNSHIP OF CHESTERFIELD ORDINANCE 2022-8

## AN ORDINANCE OF THE TOWNSHIP OF CHESTERFIELD AMENDING CHAPTER 183 OF THE CODE OF THE TOWNSHIP OF CHESTERFIELD TO ESTABLISH PARKING RESTRICTIONS ON PORTIONS OF WRIGHT DRIVE AND THORN LANE

**WHEREAS**, the Chesterfield Township Police Chief has investigated parking in the vicinity of the Chesterfield Elementary School which presently occurs so as to cause an obstruction for other vehicles, to include emergency vehicles, and

**WHEREAS**, the Chesterfield Township Police Chief has recommended portions of Wright Drive and Thorn Lane be restricted from parking, and

**WHEREAS**, the Township Committee of the Township of Chesterfield has determined that it is necessary to designate the North side of Wright Drive between Steed Lane and Saddle Way, and the South side of Thorn Lane between Bridle Lane and Saddle Way as no parking in accordance with Chapter 182 of the Chesterfield Township Code,

## NOW THEREFORE, BE IT ORDAINED AND ENACTED as follows:

#### **Article I.** Amended Sections

The Code of the Township of Chesterfield is hereby amended by revising Chapter 182, Section 26, Schedule VII: Parking, Standing and Stopping Prohibited at All Times, Sub-section B. to add the following provision:

Name of Street	Side	Location
Wright Drive	North	From Steed Lane to Saddle Way
Thorn Lane	South	From Bridle Lane to Saddle Way

### Article II. REPEALER, SEVERABILITY AND EFFECTIVE DATE

- A. <u>Repealer.</u> Any and all Ordinances inconsistent with the terms of this Ordinance are hereby repealed to the extent of any such inconsistencies.
- B. <u>Severability</u>. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the Township Committee hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the Township to meet the goals of the Ordinance.
- C. <u>Effective Date.</u> This Ordinance shall take effect upon proper passage in accordance with the law.
