### **DISCUSSION**

### Algae in the basins

Ms. Scarafile sent a memo to the Township Committee however it was not received in time for their meeting. They will talk about it at the next meeting which Ms. Romeu and Ms. Scarafile will attend. Ms. Romeu biked around and the ponds look 80% clear if not they are better. The pond on Recklesstown at the end of Berryland doesn't look good. Mr. Liedtka stated the aerator in the middle had a slice in the cord and the one on the edge needs to be pushed out which will take care of that end. Ms. Romeu stated that the aerators are working now. Ms. Scarafile stated that the pond on Recklesstown Way has some algae ono the bank but fairly clear.

### New Tree

The oak tree was planted, Ms. Romeu stated that everyone is taking turns watering it, she would like to thank DPW for planting it. Mr. Liedtka will ask DPW to put a watering bag on it, Ms. Ryan will put mulch around it.

#### INVITATION FOR PUBLIC COMMENT

Mr. Liedtka, 103 Old York Road. He asked the board if anyone would be interested in leading a project for a pollinator garden at the Municipal Building. Ms. Ryan said she would be interested, Mr. Liedtka asked her to put together a list of plants, no location is picked out however it will need irrigation so the spot shouldn't be too far from the building. Mr. Ryan said the best time to start would be early fall, late September would be best. Ms. Romeu and Ms. Koetas-Dale also volunteered to help out.

Ms. Ryan asked Mr. Liedtka about the berm around the Police Department. He said that Chief Wilson wanted a little security and also to block light pollution to the neighbors house. Ms. Ryan asked what the final look would be, he stated that there would be some sort of shrubs planted on top and mulched for easy maintenance. Ms. Ryans concern is what will happen after a heavy rain fall. Mr. Liedtka stated he would make it a 3 to 1 grade, the drainage will go between the two berms. She was also concerned about the impact on the roots that were run over while building the berms. Mr. Liedtka suggested using an aerator to help and the gypsum get into the ground which will be more effective.

Hearing no further public comment, a motion was made by Mr. Spence second by Ms. Dyson to close the public comment.
