A CAPITAL ORDINANCE OF THE TOWNSHIP OF CHESTERFIELD AUTHORIZING THE APPROPRIATION OF \$ 50,000.00 FROM THE RECREATION FUND FOR PURCHASE OF 1.2+/- ACRES, KNOWN AS BLOCK 107.02 LOT 1 AT 120 BORDENTOWN-CROSSWICKS ROAD CHESTERFIELD N.J., FOR RECREATIONAL PURPOSES

BE IT ORDAINED by the Township Committee of the Township of Chesterfield as follows:

<u>SECTION 1.</u> There is hereby approved as capital projects within the Township of Chesterfield, but not limited to, the Purchase of approximately 1.2 +/- acres, known as Block 107.02 Lot 1 at 120 Bordentown-Crosswicks Rd, for Recreational Purposes not to exceed \$50,000.00.

<u>SECTION 2.</u> There is hereby appropriated from the Chesterfield Township Recreation Fund the sum of \$ 50,000.00 to cover the cost of the projects described in Section 1.

<u>SECTION 3.</u> This ordinance shall take effect upon final adoption and publication in accordance with the law.

<u>SECTION 4.</u> The Capital Budget of the Township of Chesterfield is hereby amended to conform with the provisions of this Ordinance to the extent of any inconsistency therewith. The resolution in the form promulgated by the Local Finance Board showing full detail of the temporary capital budget and capital program as approved by the Director of Local Government Services is on file with the Clerk of the Township and is available for public inspection.
