#### REPORTS & ADMINISTRATION

Mayor Panfili asked Mr. Hirsh for any updates. Mr. Hirsh stated Phase IV Sykesville Road DOT project has been approved for bidding. That is the area from the bridge toward route 537. Sykesville Road Phase V has been approved for a grant in the amount of \$226,340. This is the balance to get to Route 537. He stated the Handicap Improvement Project is completed. In January, there is a Recreation Improvement Grant which he will submit for.

Mr. Sahol stated he contacted the County and they have advised that the 2022 Paving Contract has been awarded. This is for Bordentown-Crosswicks Road in addition to the ADA ramps, sidewalk and other improvements in the village of Crosswicks. This should probably begin in the spring. Mayor Panfili asked about the additional speed bump on Buttonwood. Mr. Sahol stated the County advised that while they are working out there this can be done through a shared service agreement and they would incorporate it into their project. There would be a cost share to the Township.

Mr. Sahol stated the County anticipates awarding a design consultant for the round-a-bout for the Old York Rd, Chesterfield-Crosswicks Rd and Margerum Rd intersection in the very near future.

Mayor Panfili asked about the status of the cricket pitch dugouts. Mr. Hirsh stated he met with Troy on site and he is developing the sketches that can be used for bidding purposes or see if the Public Works Department can do the project.

Mayor Panfili asked Tom to pass on to the county a thank you for addressing the problem on Route 528 due to the truck traffic from the laydown yard in North Hanover.

Mayor Panfili stated he met with the school last week and the lights are working and asked if we are going to move forward with the solar lights or go with something permanent. Mr. Sahol stated he would recommend staying with the solar if that works as the permanent light would have a larger cost and PSE&G would need to dig up the area. Mayor Panfili asked Mr. Gillespie if the land transfer with the school is something that can be considered. Mr. Gillespie stated one of the problems will be that they want to use some of the property for a parking lot. Also the lot will need to be subdivided. He stated you would need the State, Green Acres and County approval for all this to happen. It would be a heavy lift. Mr. Gillespie explained how the school property was purchased and the restrictions. Mr. Liedtka suggested maybe the school can relocate the playground and basketball courts and place the parking there. Mr. Panfili stated that previously the committee discussed the land swap but that the firehouse property and lot across the street would need to be considered. He stated that parking is an issue in Crosswicks and that is a way it could be addressed.

#### PUBLIC COMMENT

Mr. Liedtka made a motion seconded by Ms. Blazic to open the meeting to public comment. All were in favor.

Lorrie Thier – 40 Foulks Lane – Ms. Thier asked how long the basins were going to remain drained and thought this was going to be taken care of before everything froze. She asked for an update on the Pickleball Court and if the gate could be made wheelchair accessible. She also stated she walks 5-6 miles every other day and notices a lot of speeding on Recklesstown Way and asked about speed bumps on the long stretches.

Hearing no further public comment Mr. Liedtka made a motion seconded by Ms. Koetas-Dale to close the meeting to public comment. All were in favor.

Mayor Panfili asked Troy to respond regarding the basin drainage. Troy stated the best way to get rid of the materials is to lower the water level below the frost line of the root system. This is done over the winter and the hope is that they freeze and die off. There are only a few of the basins designed so that they can be lowered. This is the least invasive way to address the issues. The basins are maintained year round. Each basin will be assessed annually.

Chief Davison asked Ms. Thier when she notices the speeding issue. She stated it is usually right after the kids are in school and she walks for 2-3 hours. She stated the area between Harness and Preservation intersections is the area she notices. Chief Davison stated he will direct the patrols to that area more during those times.

Mr. Hirsh stated they can have the ADA gates installed for the pickleball court. That is not a problem. After the weather breaks, there will be a little more grading done for the soils which are holding the water from draining. Final coating will be done when we have better weather.

Mr. Gillespie stated we have a need for executive session for matters pertaining to attorney client privilege. It will last about 30-60 minutes and action may be taken in setting up another meeting.

Mr. Liedtka made motion seconded by Ms. Blazic to go into executive session at 8:05 PM. Resolution 2022-12-16. All were in favor.

Mr. Liedtka made a motion seconded by Ms. Koetas-Dale to return to regular session at 9:02 PM.

Mr. Gillespie explained the agenda items will be listed in the public notice. The first item will be executive session and when returning to regular session there will be a resolution for approving the agreement. The committee doesn't have to approve the agreement but at least the resolution will be on the agenda so the public can see it. Ms. Koetas Dale made a motion seconded by Ms. Blazic to schedule a special meeting on December 21<sup>st</sup> at 4:00 for purposes of attorney client privilege, and personnel/contract negotiation. All were in favor.

Mr. Liedtka made a motion seconded by Ms. Blazic to adjourn the meeting. All were in favor. Meeting adjourned at 9:04 PM.
